

**RESOLUTION 2014-47**

**A RESOLUTION TO AMEND THE LOCATIONS OF ONE-WAY HIGHWAYS  
AND PROHIBITED TURNS FOR THE VILLAGE OF MUKWONAGO**

**WHEREAS**, the Village Board, based on recommendations by Village staff, has determined that it is more cost effective to amend and more administratively effective to maintain the locations of one-way streets and prohibited turns in a resolution rather than an ordinance; and

**WHEREAS**, some changes have been made during the transfer of the information from Sections 82-121 and 82-123 of the Municipal Code to this resolution; and

**WHEREAS**, the Village Judicial Committee has reviewed said locations of one-way streets and prohibited turns and recommends amending said locations;

**NOW THEREFORE**, the Village Board of the Village of Mukwonago hereby modifies such locations of one-way streets and prohibited turns as defined in the attached schedule and be effective on December 16, 2014 and remain in effect until changed by resolution of the Village Board.

**ONE-WAY HIGHWAYS AND PROHIBITED TURNS**  
**In reference to Sections 82-121 and 82-123 of the Municipal Code**

**One-way highways.** The following highways or portions thereof maintained by the village are hereby designated one-way highways, and no person shall drive or operate a vehicle on any such highway or portion thereof except in the one direction designated as follows:

1. In a northerly direction on Franklin Street from its intersection with STH 83 (North Rochester Street) to the intersection with Elmwood Avenue.
2. In a northerly direction on the half circle drive in front of the Park View Junior High School from the southerly entrance to the northerly exit or north parking lot.
3. In an easterly direction on the half circle drive in front of the Mukwonago High School from the westerly entrance to the easterly exit.
4. In an easterly direction on the portion of Atkinson Street located east of STH 83.

**Prohibited Turns.**

1. *Right turns.* No operator of any vehicle shall make a right turn at any of the following locations:
  - a. From CTH ES (Main Street) on to STH 83 (South Rochester Street).
2. *Left turns.* No operator of any vehicle shall make a left turn at any of the following locations:
  - a. From STH 83 (South Rochester Street) northbound onto CTH ES (Main Street) southbound.
  - b. From STH 83 (North Rochester Street) southbound onto CTH ES (Fox Street) eastbound.
  - c. From STH 83 (South Rochester Street) southbound onto Atkinson Street eastbound.
  - d. From Front Street eastbound onto STH 83 (South Rochester Street) northbound.
3. *U-turns.* U-turns are prohibited at the following locations:
  - a. On Atkinson Street between its intersection with CTH ES (South Main Street) and Lois Street.
